Sewer Usage Rates:

1. The monthly sewer charges shall be based on the average monthly water usage for the months of January, February and March of each year. The resulting average monthly water usage for these months shall be the basis for the monthly sewer charge for the period of April through March of each year. Sewer use charges for customers of the Neligh municipal sewer system be and hereby are imposed as follows:

- a. Sewer charge of \$5.50 for each 1,000 gallons of water used by the customer, based on the monthly average water usage calculation, to a maximum of 50,000 gallons.
- b. Sewer charge of \$3.25 for each 1,000 gallons of water used by the customer based on the monthly average water usage calculation in excess of 50,000 gallons.
- c. Customer service charge of \$22.00 per month in addition to the sewer charge as set forth above.

2. Residents living in apartment complexes or mobile home courts within the City shall pay the customer service charge in addition to the sewer charges if their apartment or mobile home is individually metered.

3. The owner of any apartment complex or mobile home court that is served by only one water meter shall be responsible for a sewer fee based on the average water usage as set forth in (1)(a) above. Tenants of any apartment complex or mobile home court that are served by only one water meter shall be responsible for the monthly customer service charge as set forth in paragraph a (1)(c) above.

4. In the event that a mobile home site or an apartment becomes vacant, the owner of the mobile home court or apartment complex shall be responsible for the customer service charge as set forth above unless he/she requests that the water be disconnected.

5. The billing period for sewer service shall be the same as for water service.

6. For those residents using the municipal sewer facilities who are not connected to the municipal water system, a fixed charge of \$22.00 per month shall be charged for each connection to the municipal sewer system.
